ABOUT

Law & Order is a platform dedicated to students at all levels of post-secondary education, as well as legal and social science experts interested in writing about national or international political, social, economic, civil, and criminal issues or sub-issues from a legal standpoint. Mainstream academia tends to be dominated by established voices of the past generation that provide great insight, however we are committed to bringing an accessible, current, and youth-driven dimension to legal scholarship. Our mission is to highlight the voices of young scholars and budding legal professionals by giving them a space to share high-quality, reliable, and informative publications.

We accept weekly submissions on a rolling basis from all contributors. Submissions can pertain to any issues or sub-issues related to the disciplines of **Law** and **Social Sciences (political science, international relations and economics)**

ELIGIBILITY

Prospective contributors may belong to any discipline/academic background within legal and social sciences (political science, international relations and economics) fields. We are accepting submissions from undergraduate students, research scholars, and academicians. Submissions will be accepted as long as they are of high quality, original, relevant, and meet the academic standards of the platform. ***Law & Order*** has a zero-tolerance policy for plagiarism.

FEE DETAILS

There is no publication fee.

AUTHORSHIP

Co-authorship of up to two authors is allowed. Refrain from mentioning the name, institutional affiliation, or any other detail of the author(s) in the document during the editing stage in order to **maintain the unbiased nature of the review process.**

SUBMISSION GUIDELINES

For Law Articles

1. All submissions must be made to our email with the subject line **'Submission for *Law & Order: LAW Article*'**
2. Submissions should fall between 700-2500 words in length.
3. By submitting an article, the author undertakes that the article is an original work and has not been submitted, accepted, or published elsewhere.
4. Plagiarism will result in the rejection of the submission including self-plagiarism.
5. The content should be written in Times New Roman Font with a size of 12. Line spacing should be 1.5, Justified.
6. The article should contain **footnotes** and a **bibliography**. All footnotes must be in Times New Roman font, with size 10 and line spacing. The bibliography is a list of all sources used that should be included at the end of the article. Citations are to be of credible quality and must follow the **Bluebook, 19th edition**.
7. Submissions must be made in .doc/.docx formats only. Documents in pdf formats shall not be considered.

8. Authors must include their full name, year of study, name of institution/ organization, phone no. and official email ID in the body of the e-mail, and not in the body of the manuscript.

REVIEW PROCESS

1. All texts will go through two phases of peer review: a) preliminary review and b) in-depth review.
2. At the end of the preliminary review, the authors will be informed of the decision of the editors regarding the acceptance or rejection of the piece within seven days of submission.
3. If a text is accepted in the first phase, we will request the consent of the author for an in-depth review of the submission in the second phase of the editing process, wherein they must confirm that the piece will not be published on any other blog/website during the peer-review process being conducted by *Law & Order*. The decision along with any amendments and suggestions shall be communicated to the authors at the earliest.
4. If the text is selected for publication, the authors will be expected to perform any necessary revisions in good faith. Authors are also expected to cooperate in a timely manner when it comes to minor editorial changes that could arise even after the revisions made during Phase 2.

EDITORIAL POLICY

1. *Law & Order* follows a comprehensive two-fold process of peer review. The Board of Editors will keep the author(s) informed about the current status of their manuscript as it goes through each stage of review.
2. The Board of Editors will retain complete discretion over the acceptance or rejection of manuscripts
3. The Board of Editors will not entertain requests for advance decisions based on abstracts, topic proposals or outlines. Editorial decisions shall be based solely on a review of the final manuscripts submitted by the author(s).
4. Upon acceptance of the manuscript for publication by the Board, the copyright over the manuscript is vested in *Law & Order*. However, the moral rights over the manuscript shall be vested in the author(s).
5. The Board of Editors believes in preserving the original voice of the author's work. Therefore, no edits to the entry will be made unilaterally. All suggestions and comments for editing will be communicated via email, and will require the approval and agreement of the author. The authors should be prepared for a back-and-forth process of editing.

6. Upon acceptance of the manuscript for publication, the work cannot be submitted to another blog/platform. *Law & Order* accepts exclusive publications only.

PERKS

1. An e-Certificate will be issued via email, acknowledging the hard work and skilled contribution of the author to the platform.
2. High quality research papers, articles, or case comments may get an opportunity to work under our editorial team as a 'Research Associate.'
